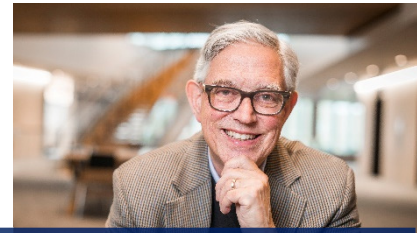

He began his career in marketing at General Mills and held leadership positions in marketing and strategy at Kraft.

Doug is also Former Chairman and Current Board Member of CECP—Chief Executives for Corporate Purpose—and a member of the board of The Partnership for Public Service. He recently retired as Chairman of The Higher Ambition Leadership Alliance, and as a board member of the National Organization on Disability and Hope College. Previously, he was Chairman of The Conference Board, Chairman of the Grocery Manufacturers Association, and Chairman of Enactus.
